3RD AFFIRMATION OF YAN YU YING

I, Yan Yu Ying, of I

do solemnly, sincerely and truly affirm and say as

follows: -

- 1. I am the Plaintiff in this action.
- 2. I make this affirmation in support of the inter-partes summons dated 8 August 2025.
- 3. Unless otherwise stated, the facts and matters deposed to in this Affirmation are true and are derived from my personal knowledge or my perusal of the relevant documents. Where there are facts and matters not within my own knowledge, they are derived from such sources of information specifically indicated below and true to the best of my information and belief.

AMENDMENT AND VARIATION CONCERNING D1

- 4. By the Order of the Honourable Mr Justice Lok dated 30 July 2025, the 7th Defendant was joined to the action. The 7th Defendant is/are person(s) unknown described by cryptocurrency addresses.
- 5. For the sake of consistency and clarity, I am advised to narrow the scope of the description of "person(s) unknown" in respect of D1, and describe D1 by cryptocurrency address in like manner.
- 6. The proposed amendments are shown in the Draft Re-Amended Writ of Summons and the Draft Re-Amended Statement of Claim.
- 7. I refer to the Recoveris.io Report dated 24 March 2025 exhibited in the First Affirmation of Chow Kam Pui as "CKP-1 [11]". I am advised and believe that the 361 Bitcoins were first transferred from the Subject Addresses to one address. Thus, the owner or operator of that address was the first recipient of the 361 Bitcoins, and also the person whom I wish to target.
- 8. In consequence of the proposed amendments, D1 would only be referred to as the owner or operator of the said cryptocurrency address ("the D1 Address" as defined in Paragraph 2 of the Draft Re-Amended Statement of Claim).
- I am advised and believe that if the Honourable Court allows the proposed amendments, it would be sufficient to serve documents on D1 by Bitcoin Ordinal Airdrop to the D1 Address.
- 10. Therefore, I am also advised to seek a variation of the order for substituted service in respect of D1, to the effect of changing the target address for airdrop from three Subject Addresses to the D1 Address only.

2ND BTO AGAINST D2

- 11. On 27 March 2025, the Honourable Court granted Bankers Trust orders against D2 to D6. The scope of the disclosure was limited to the cryptocurrency addresses identified in the Recoveris.io Report dated 24 March 2025.
- 12. I refer to the Bitrace Report dated 23 July 2025 exhibited in the Fourth Affirmation of Chow Kam Pui as "CKP-9". It was discovered that:-
 - 12.1. The D7 Addresses are associated with D2; and
 - 12.2. The D7 Addresses were not identified in the Recoveris.io Report and were not within the scope of disclosure of the Bankers Trust Order dated 27 March 2025.
- 13. While the identity of D7 remains unknown, I am advised and believe that a Bankers Trust order against D2 would be necessary:
 - 13.1. It was discovered that D7 holds parts of the 361 Bitcoins;
 - 13.2. D2 holds client account information of D7's Addresses;
 - 13.3. There is a real prospect that the information may lead to the location or preservation of assets to which I am making a proprietary claim; and
 - 13.4. The potential advantage of the disclosure outweighs the detriment to the person against whom the order is sought, not merely in terms of costs but by way of invasion of privacy and requiring breach of obligations of confidence of the exchange to the customer.

DISPENSATION WITH SERVICE OF THE SUMMONS

14. To my knowledge, all Defendants except D3 have not filed and served the Acknowledgment of Service of Writ of Summons. 15. I humbly pray the Honourable Court to grant the orders sought.
