Leave be granted to serve the INJUNCTION PROHIBITING DISPOSAL OF ASSETS WORLDWIDE AND IN HONG KONG AGAINST THE 1st DEFENDANT and *EX PARTE BANKERS TRUST* ORDER AGAINST 2nd, 3rd, 4th, 5th AND 6th DEFENDANTS dated 27 march 2025 ("**Order**") and the Concurrent Writ of Summons in the action to be issued out of jurisdiction.
- 2. Leave for substituted service of the Order, the Concurrent Writ of Summons and subsequent court documents as per the Order.
- 3. Liberty to apply.
- 4. Costs reserved.
