- 1. I am a recent PhD graduate of the Department of Computer Science, the University of Hong Kong.
- 2. I am duly authorised by the Plaintiff to make this affirmation on her behalf.
- 3. I am instructed by the Plaintiff's solicitors Messrs Edwin Yun & Co ("EYC") to carry out the substituted service order against the 1<sup>st</sup> Defendant in this action on an urgent basis.
- 4. For the avoidance of doubt, I have a broad familiarity with information technology and cryptocurrency, and I believe I have the competence to carry out the service required of me.
- 5. Unless otherwise stated, the facts and matters deposed to in this Affirmation are true and are derived from my personal knowledge or my perusal of the relevant documents. Where there are facts and matters not within my own knowledge, they are derived from such sources of information specifically indicated below and true to the best of my knowledge, information and belief.
- 6. My role in this case is simply to assist EYC to conduct substituted service as ordered by the Honourable Court. I do not know the Plaintiff personally and have no personal interest in the outcome of this action.

- 7. In full and frank disclosure, one of my PhD supervisors was Dr CHOW Kam Pui, who has previously affirmed two affirmations in this action.
- 8. I do not believe that the fact that I conducted research with him (and am joint author with him in some papers) has any influence on how I conduct the tasks required of me by EYC.

- 9. I am advised by EYC and believe that

- 14. However, to my knowledge and believe, there are no issues with the website which would prevent an ordinary web user (with an internet connection and a browser) to visit the website and view/download the court documents there via the provided hyperlinks.
